

Kick start your Bachelor of Business (Hotel Management) degree with a \$10,000* Academic Scholarship

Working in some of the world's most exotic locations in luxurious surroundings as a highly trained, well paid professional is the dream of most hospitality and tourism students – with an Australian International Hotel School (AIHS) scholarship valued up to \$10,000 you could make that dream a reality.

The up to \$10,000 AIHS Scholarships are awarded on the basis of academic excellence as well as an assessment of leadership potential. The scholarship is applied to the successful student's tuition fees with applications open to both national and international students.

Scholarship applications to the Bachelor of Business (Hotel Management) Degree Program are considered using selection criteria that reflect the management focus of the program and its objective of developing future leaders of the Hospitality and Tourism industries. Scholarships are awarded on the basis of attributes such as:

- * Outstanding academic achievement based on recent academic records
- * Evidence of leadership participation – this might include involvement as a volunteer or in a music, sporting or community group
- * Written academic references
- * Motivation, interest and aptitude for the hospitality and allied industries

**AIHS Scholarships are awarded up to the value of \$10,000 payable in three equal instalments over your first three academic terms. It is not offered as a cash payment or in any other form. All amounts are shown in Australian dollars*

What type of Scholarship is awarded by the AIHS?

The AIHS awards Scholarships on the basis of your final secondary schooling results and/or results obtained from recent Certificate or Diploma qualifications. In addition, the AIHS considers your performance in the workplace and/or demonstrated leadership capacity.

How is the AIHS Scholarship paid?

The Scholarship is awarded over your first three academic terms in three equal instalments, offsetting the fees for that particular term.

What expenses will the AIHS Scholarship cover?

The Scholarship covers AIHS tuition fees up to the total value of \$10,000. Further expenses such as the remainder of your tuition fees, textbooks, meals, computers, accommodation and other living expenses are your responsibility.

If I receive an AIHS Scholarship, can I defer it for a later intake?

Yes, your AIHS Scholarship can be deferred for up to twelve (12) months for legitimate purposes such as student exchange programs or industry work placements. The Director of the Australian International Hotel School will consider written requests for deferrals.

Are there any circumstances under which my AIHS Scholarship might be revoked?

Yes. AIHS Scholarships may be revoked due to poor academic performance in any of your first three academic terms or, at the discretion of the Director of the Australian International Hotel School, for poor conduct.

How do I complete my Application?

You need to complete the *AIHS Application for Admission Form* and tick the 'AIHS Scholarship' box in Section 7. You are required to provide evidence of your secondary schooling results and any other Certificates or Diplomas you have completed. A resume and an academic reference are also required.
